

Hogsmeade™ Hunt Instant Win Game & Sweepstakes **Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

Hogsmeade Hunt Instant Win Game & Sweepstakes (the “**Promotion**”) consists of two components: (i) an Instant Win Game (the “**Game**”); and (ii) a random draw Sweepstakes (the “**Sweepstakes**”). The Game starts at 9:00 a.m. Pacific Time (“**PT**”) on 3/1/16 and ends at 9:00 a.m. **PT** on 3/21/16 (the “**Game Period**”), and the Sweepstakes starts at 9:00 a.m. **PT** on 3/1/16 and ends at 9:00 a.m. **PT** on 3/21/16 (the “**Online Sweepstakes Period**”) for entry online, with methods of entry as detailed below. The sponsor of the Promotion is Universal City Studios LLC d/b/a Universal Studios Hollywood, 100 Universal City Plaza, Universal City, CA 91608 (“**Sponsor**”). The Promotion is subject to these Official Rules (the “**Official Rules**”), and by entering, entrants agree to be bound by them.

The promotion site (www.hogsmeadehunt.com) (the “**Promotion Site**”) database clock will be the official timekeeper for this Promotion.

This Promotion is in no way sponsored, endorsed or administered by, or associated with, Facebook or Twitter. You understand that you are providing your information to Sponsor and not to Facebook or Twitter. Any questions, comments or complaints regarding this Promotion should be addressed to Sponsor and not to Facebook or Twitter.

ELIGIBILITY

Promotion is open only to legal residents of the fifty (50) United States of America and the District of Columbia, who as of the date of their entry into the Sweepstakes are thirteen (13) years of age or older or the parent or legal guardian (“**Parent**”) of children who are age between the ages of thirteen (13) and eighteen (18) at the time of entry (each an “**Entrant**”). An Entrant who is under the age of majority in Entrant’s state of residence (18 years except: Alabama and Nebraska - 19 years; Mississippi - 21 years), must have permission from Entrant’s Parent prior to entering this Sweepstakes or Game, and such entry shall be deemed submitted by an Entrant’s Parent and shall be treated as if an Entrant’s Parent had made such entry, regardless of the method of entry. Employees, officers and directors of Sponsor, and each of the foregoing entities’ affiliates, and any other Sponsor-authorized designees associated with the design, administration, prize supplying or prize fulfillment of the Sweepstakes (collectively, the “**Promotion Entities**”), as well as members of such employees’, officers’ or directors’ immediate families (spouses, children, siblings, parents, grandparents, grandchildren) or household members of each employee (whether or not related), are not eligible to participate in the Promotion. The Promotion is void in Puerto Rico, all U.S. territories and possessions and overseas military installations and where prohibited or restricted by law. A prize won by an individual considered a minor (“**Minor**”) in his/her state of legal residence will be awarded in the name of Minor’s Parent.

HOW TO PLAY THE GAME:

To play the Game during the Game Period, individuals may (i) log on to the Promotion Site or (ii) follow the directions to log in to the Promotion Site as directed either via Facebook log-in or registered email address log-in (and if email address is not already registered, by providing the personal information as required therein: first and last name, email address, daytime telephone number, zip code, and date of birth); and then (iii) fill out the entry form on the Promotion Site; (iv) click on the button to agree to the Official Rules and Privacy Policy; and (iv) click on the “Submit” button located therein. Completing the foregoing to conclusion will result in one (1) “**Game Play**”. **ALL GAME PLAYS MUST BE RECEIVED BY 9:00 A.M. PT ON 3/21/16.**

ONLY ONE (1) GAME PLAY PER PERSON/E-MAIL ADDRESS PER DAY DURING THE GAME PERIOD WILL BE ACCEPTED. ANY ATTEMPTED GAME PLAYS IN EXCESS OF THAT LIMIT SHALL BE DEEMED VOID.

GAME PLAY WINNER DETERMINATION:

The individual who is the first player to play the Game on or after each of the two (2) randomly selected daily Game winning times during the Promotion Period will receive a Game message that says **“Congratulations! You are an instant winner. You have won a Harry Potter™ Collectible Hero Wand”** and that individual will win a Game Play prize, subject to verification of eligibility. At the time of notification instructions will be provided on claiming the prize. If prize remains unclaimed at the conclusion of the Game it will not be awarded.

GAME PLAY PRIZE:

Two (2) Game Play prizes are available to be won during each of the twenty-one (21) days of the Game: Each Game Play prize consists of a Harry Potter™ Collectible Hero Wand. The Approximate Retail Value (“ARV”) of each Game Play prize is thirty-nine dollars and ninety-five cents (\$39.95). The total ARV of all Game Play prizes is one thousand, six hundred and seventy-seven dollars and ninety cents (\$1,677.90). Odds of winning a prize in the Game depend on the number of eligible Game Plays received each day and the timing of such Game Plays.

HOW TO ENTER THE SWEEPSTAKES:

There are three (3) ways of receiving entries in the Sweepstakes: (1) by initially finding Hogsmeade items (as described at the Promotion Site) (the “Hogsmeade Item Entry”) online via Initial Method #1 (as described below); (2) by initially finding Hogsmeade items online via Initial Method #2 (as described below); and (3) after entering via Initial Method #1 or Initial Method #2, by then sharing that entry on Twitter. Initial Method #1: (i) log onto Promotion Site (as detailed above); (ii) follow the directions at the Promotion Site for finding “Hogsmeade items” at the partner sites (each a “**Partner Site**” and collectively “**Partner Sites**”) including, but not limited to the list below; (iii) follow the appropriate Partner Site links for the specific Hogsmeade items; and (iv) when finding a Hogsmeade item at a Partner Site, clicking on it.

Initial Method #2: (i) Find a Hogsmeade item on a Partner Site; (ii) click on it; and (iii) when connected to the Promotion Site, log in to the site when directed as detailed above.

The Hogsmeade Item Entry takes place (subject to the maximum number of Entries stated herein) only after the logged-in entrant either clicks on or has already clicked on the Hogsmeade item as detailed above.

HOW TO RECEIVE ADDITIONAL ENTRIES BY SHARING ON TWITTER: Once a Hogsmeade item Entry has been received, an entrant may, during the Online Sweepstakes Period, share the fact that they have found that particular item via Twitter. By sharing the fact that they have found a particular item via Twitter, and subject to the maximum number of Entries stated herein, one (1) “**Shared Entry**” in the Sweepstakes will be earned by the entrant for that specific Hogsmeade item. There is a limit of one (1) Shared Entry earned per Hogsmeade item.

Hogsmeade Item Entries and Shared Entries may be referred to herein individually as an “**Entry**” and collectively as “**Entries**”.

SWEEPSTAKES GRAND PRIZE WINNER SELECTION:

One (1) potential Sweepstakes Grand Prize (“**Grand Prize**”) winner will be selected in a random drawing held on or about 3/23/16. Potential Grand Prize Winner (or if Potential Grand Prize Winner is a minor, Potential Grand Prize Winner’s Parent) will be notified by e-mail, mail, overnight delivery service and or telephone within five (5) business days of the conclusion of the random drawing. SWEEPSTAKES GRAND PRIZE:

One (1) Sweepstakes Grand Prize will be awarded in this Promotion: The Grand Prize consists of a trip ("**Trip**") for the eligible Sweepstakes Grand Prize winner and up to three (3) Travel Companions to Universal Studios Hollywood in Universal City, California.
